See you in January!



Join us in welcoming Dr. Jeremy White as he presents on the spread of the fungal disease, white-nose syndrome, and its impact on North American bat populations, especially the

federally threatened Northern Long-eared Myotis. Dr. White is a professor of Biology at University of Nebraska, Omaha, and has been active in the field of bat research throughout the state. The presentation will be held on Thursday, November 10th, at 7 p.m. - Weitz Community Engagement Center, room 201, on the UNO Dodge campus. Non-members are welcome and we encourage you to bring friends to our meetings.

The Community Engagement Center is very easy to find, and we have free parking. Using the frontage road parallel to Dodge St., turn into the northwest corner of the parking lot east of the library. Stop at the "guard house" and tell her/him that you are attending the Audubon Society meeting. Then find a convenient parking place and walk south to the building just beyond the bell tower. Field Notes from the President: By Matt Miller

Hello again, fellow Audubon Society of Omaha members. My focus for the President's Field notes is twofold: 1) ASO/ Fontenelle Forest Hilltop trail restoration project and 2) Importance of Partnerships in Conservation.

The Audubon Society of Omaha was approached last spring before our board's summer break by the Fontenelle Forest Conservation Department to partner on a hilltop savanna restoration project. This project was on a 10-acre degraded hilltop savanna at Neale Woods in North Omaha along what is known as Hilltop Trail on the far west end of the property. Autumn Olive, Honeysuckle, Tree of Heaven, and Smooth Brome are just some of the invasive species that have covered this area. With this many invasive species, this area had little-to-no wildlife or ecological benefits to the property, essentially becoming an eyesore to hikers and rangers at Fontenelle. Through a multi-staged process, contractors, Fontenelle Forest, and hopefully, ASO volunteers, will eventually return this 10-acre plot of land to a healthier state.

The first step in reconstructing this savanna was hiring a contractor to clear the majority of the invasive brush and trees, essentially creating a blank canvas. Wes Atkins of Hickory Ridge Forestry did an amazing job, giving the Fontenelle Forest work staff room to get their tractor in to till and kill off the Smooth Brome. After the seed bed is formed, ASO volunteers will have the opportunity to partner with Fontenelle Forest staff to plant

plugs and toss seed with a mix of savanna and prairie plants. The final step will be to create signs for the interpretive birding/restoration trail that will include the new restored site on Hilltop trail at Neale Woods.

The ASO board and Fontenelle Forest are extremely excited about the restoration of the land and the possibilities this trail will give both organizations. Youth/adult birding hikes, seed collection days, and education programs are all possibilities, hopefully creating more opportunities for future projects between both organizations!

The Hilltop Restoration project partnered between ASO and Fontenelle Forest shows the importance of such partnerships in environmental conservation. In my young career I am learning quickly that in the environmental world, partnerships are crucial. Whether it's through grants, volunteerism, or resource sharing, like-minded organizations can increase work capacity and provide support in a variety of forums.

From my two years of experience on the board, I know that ASO members should be proud of our organization's active role in the environmental community. ASO's donations to the Nebraska Land Trust, Fontenelle Forest, Vincent Bluff Preserve, Boys Scouts, to name just a few quick examples, shows the wide-reaching scope of the Audubon Society of Omaha when it comes to partnering to improve habitats in Nebraska and Western Iowa.

As our organization continues to adapt to changing times, I ask you the members of this powerful organization to look for opportunities to volunteer not just with ASO projects but also to get involved with other environmental organizations. Fontenelle Forest, the University of Nebraska at Omaha, Hitchcock Nature Center, Green Bellevue – these are just a few places with projects where volunteers can help.

Whether you are helping clean up trash in a natural area, killing invasive species, donating funds to various projects, or helping with a prescribed fire, it says that organizational partnerships are the blood that helps the heart beat in the environmental community!

The 117th running of the Omaha national/international Christmas Bird Count will be held on December 17, 2016. It is held in Bellevue within a 15 mile diameter circle centered on the Base Lake east of Offut AFB. The circle is divided into quadrants, two on the Nebraska side and two on the lowa side. There are four area captains and as many volunteers as possible to give a good coverage to the area. Birders of all levels are welcome. New birders will be put with experienced counters.
